- g. Proposed changes from DNR to instream flow reservations. Letter from Tim Troll sent to meeting attendees proposes a list of questions for DNR.
 - i. Question from Sen. Micciche: is DNR has authority to enact the proposed role via regulation? Intends to have staff find an answer to this question.

- i. Alaska Chapter of the American Fisheries Society is hosting a meeting March 22 25
- j. Attachment sent to meeting attendees about a study regarding light-penetrating riverbank boardwalks; pertains to Kenai Borough Anadromous Fish Habitat working group.
- k. Question from Brian Blossom regarding zinc plating on elevated walkways. Discussion from Branden on existing local literature on this topic. Additional questions and discussion regarding potential nonpoint pollution sources.

 - iii. Zinc and copper currently still in category 3
 - iv. Cu / Zn from Kenai River Baseline Water Quality Monitoring project data did not meet QA/QC standards
 - 1. DEC looking at doing a project in summer 2021 focused on assessing and improving QA/QC for CU/Zn sampling and analysis.
 - 2. The ACWA grant that had been proposed may not have been funded because it was focused on QA/QC, which is typically not within the purview of these types of grants.
