- Partnership Business Updates Melissa: The NFHP Board will be meeting in Anchorage
 this July 31 and August 1 with an optional fieldtrip to the Kenai Peninsula on August 2. I
 would like to schedule a meeting to discuss field trip options, including the crooked
 creek juvenile salmon monitoring project from 2019.
- 3. Review of FY25 proposal ranking process

 Melissa recapped the purpose of the meeting: to discuss and rank FY25 funding proposals. Explained the meeting procedure.
- 4. Presentation of Proposals and Q&A

The following people gave a two minute presentation on their FY25 proposal:

a. Alanna Shaw - Kenaitze's Kenai River Baseline Water Quality Monitoring, Kenaitze Indian Tribe. This project is adding 3 new water quality testing sites that are of concern to the tribe; one at the Tribe's educational fishery site, one near the Tribal office, and one corresponding to a hotspot. This would also be a capacity building opportunity for the Tribe. Katherine – What are your thoughts on the majority of the funds going to KWF and not the Tribe?

- Alanna This is acceptable to the Tribe since we want the work done and currently do not have the capacity to complete it.
- b. Emily Heale Marten Lake Flow Control Repairs, Cook Inlet Aquaculture Association. CIAA is seeking funding to repair flow controls, flow control structure at the outflow of Martin Lake which is in the Big River Lake system. The flow control ensures. There's adequate water flow from the lake to ensure adult salmon can make it into the system to spawn, and also, so juvenile thing make it out of the lake.
 - Emily M. Why have salmon only been documented in the system 11 out of 28 years?
 - Emily H The lake is not continuously monitored. There may have been years they were simply not observed or the flow was too low to allow passage.

 Ben How many similar structures does CIAA have throughout the Cook Inlet?

 Emily H. Three: Martin Lake, Daniels Lake, and Packards Lake on Kaligin Island.
- c. Sue Mauger Salmon Safe Agriculture Growing Practices for Farming on a Salmon Landscape, Cook Inletkeeper. This project is targeting new farmers who are converting land into farm land. We do not have a high amount of farm land on the Kenai Peninsula so we have a real opportunity to be proactive about conserving salmon habitat.
 - Ben What is the target area?
 - Sue The Kenai Peninsula lowlands, so southern and central Kenai Peninsula where the land is suitable for agriculture.
- d. Carson Chambers Baby Salmon Live Here, Kachemak Heritage Land Trust. This project is to disseminate existing science to partners and decision makers. The outreach products are "BSHL" signs, King Maker, and babysalmon.org.
- e. Samantha Lopez River Center Access and Restoration Demonstration Project, Kenai Peninsula Borough. This project would install a 32 by 6 ft. elevated walkway and 200 feet of spruce tree revetment at the River Center. This will also act ask a demonstration site for landowners to see what can be done on their own property.
 - Jess I have some ideas for project monitoring Ben – Is this ELP boardwalk replacing an old section? Samantha – No, this will be a new section of boardwalk.
- f. Brandon Drzazgowski Stream Watch: Volunteer Restoration and Outreach on the Kenai Peninsula, Kenai Watershed Forum. This projects is to fund the ongoing efforts of Stream Watch. We will train volunteers to work sites from Anchor Point to the Russian River, including litter pick up, peer-to-peer education, and restoration events. Building a community of stewardship. This also includes Stewardship days for untrained volunteers to get involved with conservation events as a group, including 3 miles of habitat protecting fence.
- g. Alexa Millward Outreach as Early Detection and Rapid Response: Raising Awareness, Aquatic Invasive Species, Trout Unlimited. This project will develop and disseminate outreach material about invasive species to the angling community primarily, including our master guide program and various public

outreach events.

Ben – how are invasive species currently reported? Ashley – The invasive species hotline is the best option.
