1. Changes to FY24 ADFG project "Soldotna Creek watershed: conserving hydrologic conditions for fish".

Leah – Without filing for instream flow reservations, the project will not change much. The majority of the project will include fieldwork and data analysis. This data will be summarized in a report and used by ADFG to make management decisions. Another significant component is fish trapping and filing anadromous waters catalog nominations. Ben will lead that field work. Completing the application for reservations only takes about an hour, so there won't be any changes to the budget. Any entity that files these applications needs to be available in the future to potentially negotiate for water use. ADFG is working on a hydrology mapping tool to make this information publicly available. Leah will let us know when the map is completed.

- 2. Coordinator updates: RFP, Application for Congressional Designation, etc. Melissa:
 - a. RFP distributed last Friday (11/17). Thank you to those who provided input on the RFP. Webinar December 11th, 11:00am to noon. Go over the RFP in detail. Look at some of the changes in the application and scoring from prior years. Answer any questions.
 - b. Congress Des: final stages of completing the application now. Will submit to steering committee around Dec 1 for feedback. Looking for any specific details or historic work we've done that I may have missed. Will need any comments back by Dec 15th.
 - i. Draft application is due December 31st
 - ii. NFHP Staff thinks all FHPs have a great chance of getting designation
 - iii. Other great byproducts of the application: filled in gaps in historic projects on website. Added a lot of project summaries and reports, including data sets to historic projects page. We now have project metrics summarized for all historic projects.
 - c. FY24 NFPP (Nat'l Fish Passage Program) BIL Funding Opportunity Proposal update. Letter of intent submitted last Friday. Received support from 18 of the 20 FHPs. Thank you to everyone for your feedback.

i. Improve barrier inventories. Funding for each FHP to complete the work. Here is an example from Sara Strassman, coordinator for the Driftless Area Restoration Effort (DARE):

DARE kicked off a road stream crossing inventory effort in the summer of 2023 and has groundwork laid for 2024. Our model of field data collection through seasonal interns has been successfully deployed across the Trout Unlimited enterprise and has completed a successful season in 2023 surveying more than 1,000 crossings. A four-person, summer crew with equipment, travel and salary expenses built in requires \$75,000. Therefore, a request of \$150,000 could fund 2 additional crews, expanding our work area by 8 additional counties. We would be creating 8 new positions per year and with stable funding, could retain select crew leads between seasons to conduct additional outreach and training with local road managers.

- ii. Support partner planning efforts, includes \$10K per participating FHP
- iii. Fund fish passage project design and implementation

- iv. Outreach efforts
- v. \$5-10 Mil total budget, mostly for design and implementation
- vi. Assoc. of fish and wildlife agencies fiscal sponsor
- vii. FWS BIL Fish Passage Program staff determined a national lever LOI would not score well. No funding in this program for planning and outreach. Projects need to address specific on the ground projects on a regional level. NFHP staff and coordinator will meet at the end of the month to discuss if there is a way to move forward.
- Annual Membership Meeting should we have one? Last membership meeting was in 2018. One benefit would be filling the gap between years with no symposium. Ben, Maura and Erika supported hosting a membership meeting in January or February of 2024.

Erika – NOAA will be hiring a new employee. This will be a good opportunity to introduce them to the group. This new hire will be taking over my role on the Steering Committee.

- 4. Should we meet in December? Not supported. We will schedule our next meeting for January 2024.

Trent – KWF submitted a LOI for that funding opportunity. The project would replace a culvert in the Soldotna Creek drainage upstream of the highway work that will start next summer.

Ben – Has identified 17 miles of stream within 30 mins of the office that can be sample for Anadromous Waters Catalog nominations. Ben is partnering with TU for this project. Fieldwork will be completed summer 2024. This will include a new mapping tool: Net Map - <u>https://terrainworks.com/get-netmap-virtual-watersheds-and-tools</u>
