- 2. Infrastructure bill continues to have ripples statewide. Most actual construction work will begin in future years
- 3. Project w/ Hilcorp in KNWR, they have funded many culvert improvements. USFWS also working in Ninilchik area.
- 4. Port Graham to Rocky lake project; partnership w/ USFWS and several other local/federal entities, is progressing

## Appendix A: Written notes from Samantha Lopez, Kenai River Center director

Updates for the River Center: we had a week-long audit with FEMA going over the Kenai Peninsula Borough's floodplain management program.

Some of you may recall two years ago there were some issues when FEMA rescinded a fish habitat structure policy. The policy allowed for bank restoration projects to be installed without requiring some very expensive engineering calculations.

During the audit, we were able to come to an understanding, effectively closing the case on this. We will be able to continue permitting habitat protection projects across the peninsula without requring that engineering analysis. Its a little bit more in depth than that, but that's essentially the takeaway.
